Additionally, while you mention that Southern states broke off and formed the Confederacy, you could have expanded on the secession process and the formation of the Confederate States of America.
- (c) To improve your writing, consider using a topic sentence to introduce your answer and a concluding sentence to summarize your main points. For example, you could start with: "The American Civil War was triggered by a series of events, including the Lincoln-Douglas debates, John Brown's raid on Harpers Ferry, and the election of 1860." At the end, you could add a concluding sentence: "In conclusion, these three events were influential in leading to the Civil War because they drew attention to the issue of slavery and fueled tensions between the North and the South."
